2) Breeding Service is purchased on a "First Come, First Serve" basis, determined by date/time of postmark (if mailed) or date/time of email, at 1/2 the advertised Breeding fee (or fair market value as determined by Stallion owner/lessee/agent if advertised as Private Treaty).
3) Purchaser shall receive confirmation of purchase once payment of "good funds" are received.
4) Once conceived, and the foal is verified IN UTERO: The foal shall be automatically nominated into the Arabian Breeders Challenge Futurity. (Foal shall receive initial IN UTERO nomination with NO additional nomination fee and be eligible to compete as a weanling).
5) If the foal is born in Colorado: The foal shall also be automatically registered as a Colorado-Bred Runner in the Colorado-Bred Racing Arabian (CO-BRA) Program. (Foal shall receive initial registration with NO additional registration fee.) The foal MUST BE born in Colorado, from a Colorado Brood-Stock registered DAM at the time of foaling. (Please contact CABA to register the mare if not already registered {the mare's fee will be assessed}).
6) The applicable nomination/registration forms must be completed and submitted to the CABA administrator of the respective program.
7) Individual breeding contract shall be negotiated and executed between the party responsible for the Mare's breeding and the Stallion's owner/lessee/agent. This purchase contract, in its entirety, is solely for the cost of the "STUD FEE".

"CABA highly recommends that the winning bidder contact the stallion owner to determine any additional fees such as semen collection, semen shipping, etc."
